2010 ANNUAL PHOTO COMPETITION

Categories	1. People	Photographs featuring people as the primary subject.
	2. Children	Photographs featuring children as the primary subject.
	3. Places	Scenes, landscapes and architecture as the primary subject.
	4. Still Life	Photographs of inanimate objects, typically arranged by the photographer
	5. Documentary	Photojournalism, special events, (concerts, the Dance, theatre)
	6. Animals	Photographs with animals (insects included) as the primary subject. (Macro included)
	7. Plants	Photographs featuring the wide variety of flora (Macro included)
	8. Open	Photographs that are abstracted, artistic or extensively manipulated. This is the place for Photographic images that just do not fit any of the other categories.
	9. Youth	This category is open to anyone 18 years of age and younger on contest day. Youth photos may be of any subject matter. All photographs will be grouped in a single category.

Rules

1. The Entry fee is \$10.00 for each photograph. There is no limit on the number of entries.
2. Each entry must be an original photograph taken by and the property of the entrant, identified by a LABEL permanently attached to the top back of the foam core backer board.
3. No commercial names will be allowed on the front of the photographs. Individual names on the front of the photographs are discouraged and will be covered during the judging process.
4. Photographs previously submitted to a CAMERA SOUTH annual competition are not eligible. All entries must be mounted on a 16" x 20" mat board or foam core backer and cannot be more than 1/4" in total thickness. Horizontal and vertical formats are acceptable. Poster paper is not acceptable as a backer board. Minimum print size 80 square inches (8 X 10 equivalent). Any photograph not mounted on a 16 x 20 backer will not be accepted. **ALTHOUGH CLEAR PROTECTIVE COVERS ARE NOT REQUIRED THEY ARE HIGHLY RECOMMENDED**
5. Nudes will be judged but will not be displayed.
6. Ribbons will be displayed on winning photographs and must be left in place throughout the entire show. Early removal will result in forfeiture of all prizes. Anyone who receives a ribbon must agree to having their photo put on display at Calagaz Photo and Digital Imaging from October 18, 2010 through October 23, 2010. Winning photographs will be available for pickup between October 25, 2010 and October 30, 2010 at Calagaz Photo and Digital Imaging.
7. Non-ribbon winning entries may be picked up between October 18, 2010 and October 30, 2010. Prints not picked up by Oct. 30 will become the property of CAMERA SOUTH and will be disposed of as determined by CAMERA SOUTH
8. Any deviation from these rules will result in the photograph not being eligible for judging and the forfeiture of the entry fee. Decisions of the Exhibition committee and the judges will be final.
9. All images will be judged in the Category shown on the Official Entry Form as recorded by the Entrant.
10. Judging will be held at Calagaz Photo and Digital Imaging on Saturday Oct. 9 beginning at 9:00 a.m. The public is invited to attend and participate. Independent judges and their family members are not eligible to enter photographs.
11. Prints will be hung (as space permits) in Bel Air Mall from Sunday, October 10 through Saturday October 16, 2010. Camera South cannot guarantee that all prints will be exhibited.
12. There will be a \$35.00 charge for any returned checks.

CAMERA SOUTH will take every precaution to protect photographs against loss or damage; however the CLUB nor the firms handling the prints can be financially responsible the photographs entered.

Please make sure that all forms are filled out completely and are attached to the OUTSIDE of the PRINT.

IF YOU ARE USING THE PROTECTIVE SLEEVE, PLACE ALL LABELS ON THE OUTSIDE OF THE SLEEVE.
